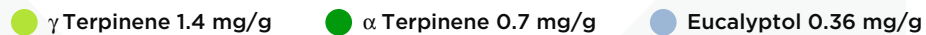

Terpenoid Analysis

Terpene analysis utilizing gas chromatography-flame ionization detection (GC-FID). Terpenes are the aromatic compounds that endow cannabis with their unique scent and effect. Following are the primary terpenes detected.

Method: QSP 1192 - Analysis of Terpenoids by GC-FID

1 γ Terpinene

One of four isomers of the monoterpene Terpinene. It has a fragrance that can be described as sweet, spicy, tropical, woody and oily with a hint of citrus. Found in marjoram, cardamom, tea tree, bible hyssop...etc.

2 α Terpinene

One of four isomers of the monoterpene Terpinene. It has a fragrance that can be described as citrusy, herbal, woody, piney with a hint of spice. Found in marjoram, cardamom, tea tree, bible hyssop...etc.

3 Eucalyptol

A monoterpene alcohol with a fragrance that can be described as a combination of fresh, spicy, herbal and minty. It is sometimes added to cigarettes and mouthwashes as a flavorant. Although sometimes used as an insect repellent, it is a powerful attractant to certain male bees. Found in eucalyptus, rosemary, wormwood, sage...etc.
