- 2) As defined by the 2018 Farm Bill, hemp must contain no more than 0.3% Total THC, defined as the concentration of delta-9 tetrahydrocannabinol ( $\Delta^9\text{-THC}$ ) post-decarboxylation - see formula above.
- 3) Total Cannabinoids result reflects the absolute sum of all cannabinoids detected.


